We act for Mr Nadhmi Auchi. We have been instructed by our client in relation to an article entitled "Obama's Chicago Arab-American network comes into focus" by Lee Cary, published on your website from 20 September 2012 at the following address:

The article contains highly defamatory and false allegations in relation to our client, in addition to other inaccuracies. In particular, which list is not exhaustive:

- 1. It is untrue that our client is in any way involved in terrorist activities, including the supplying or funding of terrorism or, as far as he is aware, on any "terror watch list" or "listed as a terrorist". It is also false that our client has been banned from entering the United States because he is on any such list.
- 2. It is untrue that our client was "[Tony] Rezko's bag man in Chicago" or "the money man for the whole [Chicago] network".
- 3. It is untrue that our client has any role in, or other connection with, an alleged "Arab spy ring operating out of Detroit".
- 4. It is untrue that our client "was involved with [Tony] Rezko in a cross section of Iraqi contract schemes".
- 5. It is untrue that our client was involved in "health and medical schemes and scams", whether in Chicago or Iraq as alleged, or at all.
- 6. It is untrue that our client was involved in "corruption" in relation to the reconstruction of Iraq, whether as alleged or at all. Our client is not involved in corruption of any kind.

Furthermore, the article contains hyperlinks, encouraging readers to access further articles containing numerous highly defamatory and false allegations in relation to our client, entitled "From Baghdad to Chicago: Rezko and the Auchi empire" and "The Arab-American network behind Obama"2.

The article published at your website, and those to which it links, contain allegations that appear to be derived from allegations previously published in the Guardian and Observer newspapers, and in a 2004 Pentagon Report entitled "Preliminary Findings: Report to the Inspector General into Mobile Telecommunications Licenses in Iraq" (the "Pentagon Report").

Our client took legal action against Guardian News and Media Limited (publisher of the Observer and Guardian) in respect of the six Guardian and Observer articles cited above which were subsequently removed from the Guardian website. The newspaper accepted that the articles contained "some significant inaccuracies". It has also undertaken not to republish them and agreed to pay a substantial sum in relation to costs. In addition, the publisher of the New Statesman has published an apology both on its website (copy enclosed) and in a personal letter to Mr Auchi in respect of similar allegations as well as paying Mr Auchi substantial damages and his legal costs.

The Pentagon Report itself has been completely discredited, and hence the claims of its author, and a key source of quotes and material in the article complained of, John A. Shaw.

We have received documents relating to the settlement of claims made by Dr Daniel Sudnick against the United States Department of Defence. Dr Sudnick was employed by the US Department of Defence as a Senior Advisor to the Ministry of Communications, Coalition Provisional Authority, between July 2003 and April 2004. The Pentagon Report claimed that Dr Sudnick was the recipient of the alleged bribes from our client and involved in our client's alleged corruption in Iraq. It is clear from the Settlement Agreement between Dr Sudnick and the United States Department of Defence, and the supporting declarations from senior individuals within the US Department of Defence, that these allegations about Dr Sudnick are false. We also understand that Dr Sudnick was re-employed by the Department of Defence in a senior position within the Department of the Navy, as a highly-qualified expert. We further understand that as part of this re-employment his security clearance has been re-activated. In light of the above the Pentagon Report has been discredited and should not be relied upon, including in relation to claims in it which relate to our client and that are repeated in the article published at your website and those to which it links.

Further, our client has reached a favourable settlement with the publisher of The Washington Times over an article that contained allegations about our client deriving from the Pentagon Report. The Washington Times and the author of the article, Bill Gertz, have removed the article from their websites and agreed not to republish it. Furthermore, both the FBI and the Special Inspector General for Iraq Reconstruction of the US Department of Defense have informed The Washington Times that they are unaware of any basis for further investigation or legal action against our client in respect of the allegations that were made against him in the Pentagon Report.

We also refer you to The Los Angeles Times' article "Pentagon Deputy's Probes in Iraq Weren't Authorized, Officials Say" published on 7 July 2004<sup>3</sup> and to the apologies published to our client in the Financial Times and Mail on Sunday (copies enclosed).

In light of the above, you are requested to cease publishing these false and defamatory allegations about our client by immediately removing them for your website.

You should be aware that our client has lived and worked in England for over 25 years and that your article is likely to have been read by a substantial number of readers in England. Accordingly, in relation to publication of the article in England, it will be subject to English law and the jurisdiction of the court in England.
